3. DIRECTOR DESIRES YOU SEND REPRESENTATIVE TO MEET LIBERTY AND PROVIDE MAXIMUM ASSISTANCE AND GUIDANCE IN RESPECT TO NSA PERSONNEL, LOCAL LIAISON, AND INFORMATIONAL REPORTING TO NSA. ALSO RELAY THRU NSA ADPM ANY MESSAGES FROM WILSON TO WIFE.
4. WITH RESPECT TO WILSON, WISH HIM TO ASSIST NAVY SSO REPRESENTATIVES WITH ALL ASPECTS, ESPECIALLY SECURITY ASPECTS, OF CODEWORD MATERIAL ON BOARD ESPECIALLY THOSE FOUND WHEN SEALED COMPARTMENT IS OPENED. WHEN THIS IS ACCOMPLISHED REQUEST YOU ARRANGE WILSON'S TRANSPORTATION HOME BY MOST EXPEDITIOUS MEANS.
5. WITH RESPECT TO BLUE, IF BODY FOUND REQUEST REPORT TO NSA SOONEST. IN SUCH EVENTUALITY PRESUME NAVY MAKES NECESSARY ARRANGEMENTS FOR RETURN OF BODY BUT YOU SHOULD OFFER ANY ASSISTANCE THAT MIGHT BE APPROPRIATE.
6. WITH RESPECT TO BLALOCK, YOU SHOULD BE PREPARED TO DISPATCH REPRESENTATIVE TO PROVIDE COMPARABLE AND APPROPRIATE ASSISTANCE. AT THIS TIME, NSA DOES NOT KNOW HOW AND TO WHERE HE WILL BE EVACUATED FROM CARRIER AMERICA BUT WILL INFORM YOU WHEN KNOWN TO US. IN MEANTIME YOU MAY BE ABLE
