B INCIDENT TO DAMAGE RECEIVED ON 8 JUNE, USS LIBERTY REQUIRES DRYDOCKING, REMOVAL OF CASUALTIES (KIA), AND REMOVAL OF SENSITIVE EQUIPMENT AND MATERIAL FROM HULL SPACES. IN VIEW OF RECENT PRESS COMMENT, IT IS ESSENTIAL TO PRESERVE SECURITY OF LIBERTY'S CAPABILITIES AND MISSION.

2. ~~(S)~~ MISSION. TO SUPERVISE THE DRYDOCKING OF USS LIBERTY AT MALTA ON OR ABOUT 13 JUNE 1967 IN ORDER TO PREVENT DISCLOSURE OF CLASSIFIED INFORMATION AND EQUIPMENT TO UNAUTHORIZED PERSONNEL.

3. ~~(S)~~ EXECUTION. ON OR ABOUT 13 JUNE 1967, USS LIBERTY (AGTR 5) WILL ARRIVE IN MALTA, WILL CHOP TO CINCUSNAVEUR AND WILL BE ASSIGNED TO CTF 100. CTF 100 WILL SUPERVISE THE DRYDOCKING, REMOVAL AND SHIPMENT OF REMAINS OF PERSONNEL, KIA, PROTECTION OF CLASSIFIED MATERIAL, AND WILL READY USS LIBERTY FOR REPAIR BY COMSERVFOR SIXTH-FLT.

A. TG 100.1 MEDICAL GROUP. (PROVIDED BY COMFAIRD) PROVIDE FOR REMOVAL AND SHIPMENT OF REMAINS AND ARRANGE FOR TREATMENT OF CASUALTIES.

B. TG 100.2 DOCKING AND REPAIR GROUP (PROVIDED BY COMSERVFOR-SIXTHFLT) PROVIDE FOR DOKING AND NECESSARY SHIPYARD SERVICES REQUIRED INCIDENT TO COMPLETING THE F 100 MISSION.

C. TG 100.3 PUBLIC AFFAIRS GROUP. (PROVIDED BY CINCUSNAVEUR) ENSURE THAT PUBLIC AFFAIRS ARE HANDLED IN SUCH A WAY AS TO PROVIDE THE ESSENTIAL INFORMATION REQUIRED BY PRESS MEDIA, AND THAT SECURITY ASPECTS OF LIBERTY'S MISSION, CAPABILITIES AND DOCKING ARE SAFEGUARDED.

D. TG 100.4 SECURITY GROUP (DIRNAVSECGRUEUR PROVIDE) ASSUME RESPONSIBILITY FOR ALL MATERIALS REQUIRING SPECIAL HANDLING INCLUDING THEIR REMOVAL FROM USS LIBERTY, TRANSFER TO SECURE STORAGE AND CONTINUOUS SECURITY AT ALL TIMES.

3. TG 100.5 SUPPLY GROUP (PROVIDED BY COMFAIRMED) ASSUME THE RESPONSIBILITY FOR PAYMENT OF BILLS AND OTHER SERVICES INCIDENT TO TF 100 OPERATIONS, BILLETING OF PERSONNEL, TRANSPORTATION AND ALLIED FUNCTIONS.

F. TG 100.6 COMMUNICATIONS GROUP (SHIP PROVIDED BY COMSIXTHFLT IN MALTA) PROVIDES COMMUNICATIONS ARRANGEMENTS AND SERVICES REQUIRED BY TF 100.
